Hifab/Bolt Consortium, is recruiting a short-term expert for the position of Community Services Training Assistant/Supervisor – Junior Expert in the EU funded Project in Republic of Serbia: "Enhancing the position of residents in residential care institutions for persons with mental disability and mental illness and creation of conditions for their social inclusion in the local community" (Project duration September 2012 – September 2014)

The overall objective of the project is to enhance the social inclusion of persons with mental disability and mental health disorders. The project consists of three components:

- 1. Transformation plan for residential institutions and development plan for the cross-sectoral community-based social and health services created.
- 2. Implementation of Transformation & Development Plans strengthens capacity at national and local level to improve range and quality of cross services for de-institutionalization of persons with mental health disorders.
- 3. Support to the Grant Scheme¹ for provision of community based social and mental health services.

Objectives of the assignment

The objectives of the assignment are the following:

• Assist in implementation Training Plan for on-site and theoretical training based on results of the Training Needs Assessment

Assist in evaluation of the assignment and providing feedback to the future trainers.

• Assist in provision of supervisory and advisory services to trainers in conducting the training and monitor training outputs

• Experience in supervision and follow-up of on-site trainings related to the community services for the people with mental disabilities (intellectual disabilities and long-term mental distress

The positions will be based in Belgrade. The indicative commencement of the assignment is July 2014. The tasks shall be implemented within a period of time July 2014 - September 16, 2014, in total duration of thirty (30) working days for the Junior Expert position.
