- Vehicles are sold 'as is, where is'. Delegation of the European Union to Serbia will neither accept further claims regarding vehicles' conditions nor any obligations deriving from the vehicles' use after the signature of the sales contract.

- Vehicles are tax and duty free. The Buyer will bear all costs related to the sales of the vehicle (absolute rights transfer tax, re-registration, transport and any other administrative expenses). Please note that ownership transfer tax are to be borne even by diplomatic/international (non-residence) bidders.
- Payments for the vehicles should be done by bank transfer only to the account of the EU Delegation to Serbia. Cash payments are not accepted.

### **SUBMISSION OF BIDS:**

- Bid(s) should be submitted by using templates available under links provided under vehicles description section ( page 1).
- Bidders are not obliged to submit offers for both vehicles – it is acceptable to submit offer for one of the cars listed above.
- Bid(s) should be submitted in closed and sealed envelopes, addressed as follows:

- Bids should contain:
  - a) Bidders' generalia.
  - b) Price.  
 Bidder can submit prices either in Serbian dinars or in Euro value. Analysis of the offers with different currencies will be matched by using the official EUR/RSD conversion rate of the European Union ('InforEURO') of the month in which sales contract is signed will apply.

  - c) In case the Bidder is buying the vehicle for another person an authorisation for representation verified by the notary public should be submitted whereby the Bidder is being authorised by the Buyer to conduct all activities related to the purchase of the subject vehicle.
- Deadline for submission of bids is: 14.2.2023. by 15:00 hours for hand-delivered offers (in person). In case the bids are sent by regular postal service or express courier, the date of sending will be considered as the submission date/time. Late bids will not be taken into account.

### **CONTRACT AND HAND-OVER OF VEHICLES:**

- Submitted bids will be assessed by an internal evaluation committee of the EU Delegation to the Republic of Serbia.

- The vehicles are sold to the highest bidder. The highest bidder will be informed by mail/phone of the auction results and will be required to submit official identification document (identity card/passport) for the sake of preparing sales contract and other necessary documents.
- The sales will be considered completed after:
  - a) the account of the EU Delegation to the Republic of Serbia is being credited, and
  - b) Buyer submits proof of paid tax on the absolute transfer rights.
- Deadline for payment is 5 working days from the date of contract signature. In case the highest Bidder does not meet above conditions, the vehicle will be offered to the second best Bidder and so forth.
- Handover of vehicles will be done at earliest 24 hours, and at latest 72 hours after the payment is registered. The EU Delegation to the Republic of Serbia does not take any responsibility of safe-guarding the vehicle after the period for hand-over expires.
