Questions	Answers
1. Could you please clarify what is an intern-governmental organisation?	An intergovernmental organisation is an Agency set up by two or more sovereign states to carry out projects and plans in common interest. These organizations can be closely associated with the term "international organization."
2. Can one organization submit more then one proposal within different partnerships/coalitions, acting in one as applicant and in the other as a partner?	An applicant may submit more than 1 proposal under this call for proposals (either as applicant or as partner); however it can be awarded only one grant (either as applicant or as partner).
3. Could you kindly confirm that:	
i) A proposed action can cover only one type of action mentioned in the guidelines: housing, enhancing of living conditions <u>or</u> income generation activities. It is not required to have a housing component in a proposed project.	i) Yes, a proposed action can cover only one type of action.
ii) Under 3. Income generation activities, business activities and agricultural inputs are not limitative.	ii) No.
iii) Under 3. Income generation activities, market-oriented educational activities are eligible.	iii) Yes
iv) Furthermore could you kindly indicate what will be the approximate percentages of funding available for housing and for income generation	iv) The funding available for housing solutions and income generation activities is closer to 80-20 ratio.

support? (the guidelines indicate that 'it is envisaged that a higher proportion of the funding available will go towards proving housing solutions'). (Is it closer to a 60-40 ratio or a 80-20 ratio?)	
4. Is a public company eligible as an applicant?	No. In section 2.1.1 "Eligibility of applicants: who may apply", page 6 of the Guidelines for applicants it is specified that in order to be eligible for grant, the applicant must be either a non-governmental organisation, or an international (inter-governmental) organisation.
5. Are UN agencies registered in Serbia eligible applicants for this call for proposals?	Yes.
6. As stated in the very Grant Application Form under section The Applicant , " <u>Applicants that are registered in PADOR do not need to fill</u> in the rest of this section", we would be most grateful if you could confirm that one organisation having all necessary documents already uploaded in the mentioned database under its own identification number, does not need to fill in the pages from 15 to 23 of the Grant Application Form.	Applicants already registered and validated in PADOR do not need to fill in section II of the application form, except for the Name of the Organization and the Europeaid ID number, nor do they need to resubmit supporting documents.
7. In case that municipality donate the land and communal infrastructure, will it be consider as a 5% financial contribution or in kind?	Contributions involving real estate shall be excluded from the calculation of the amount of co-financing (art. 172 of the Implementing regulation).
8. What is the exact meaning of "apartment unit for life in socially protected conditions" as indicated in Guidelines?	The social housing in protected conditions is the programme that implies the construction of the apartment unit for the most vulnerable families. These housing facilities are under a jurisdiction of the municipality and local Centres for Social Work and are only assigned for the use of refugees, IDPs and local socially vulnerable population.
